A. Scope of the Work

- Coordinate in establishment of new multipurpose PACS/ Dairy/ Fishery/primary cooperative societies in all uncovered Panchayats/villages by continuous interface with all project stakeholders.
- Follow up with PACS, Dairy and Fishery cooperatives/ DCCBs/ StCBs for obtaining project proposals.
- Provide guidance to the primary societies in submitting proposals and undertaking all necessary steps for smooth implementation of the action plans.
- Support in achieving convergence with various schemes identified under the plan such as National Programme for Dairy Development (NPDD) and Dairy Processing & Infrastructure Development Fund (DIDF) of Department of Animal Husbandry and Dairying; Pradhan Mantri Matsya Sampada Yojana (PMMSY) and Fisheries and Aquaculture Infrastructure Development (FIDF) of Department of Fisheries.
- Study the existing IT system to guide the department on process improvement and facilitating real time monitoring of formation of new cooperative societies.
- Prepare periodic reports as required by Ministry of Cooperation/ NCDC.
- Regular follow up with project stakeholders for timely achievement of targets
- IT System Strengthening: PMU team shall support in maintenance of the existing system. - Only Shortlisted candidates will be called for the interview and may also be assessed for their proficiency in MS Office/ data management. Location for the interview will be indicated in the call letter. The candidates may kindly note that any cost incurred by them for attending the interview will not be reimbursed by NABCONS.
- The interview may be held in person or through virtual mode as may be required.
- The applicant may submit the declaration in the Google form with respect to the education qualification and experience. Self-attested copies of education qualifications and experience certificates are to be compulsorily submitted at the time of the interview. Original documents would be required for verification.
- Place of posting of the posts will be as per the locations mentioned in Section A above. The candidates can be posted anywhere in India depending upon the project requirement. Further, as a part of their functioning the above consultants may be required to travel across the mentioned state and other parts of the country from time to time.
